

**NOTICE OF PUBLIC HEARING BEFORE THE**  
**JOLIET PLAN COMMISSION AND**  
**JOLIET CITY COUNCIL**

**Regarding a proposal by CENTERPOINT JOLIET LLC.**

**Case Number A66-08 through A89-08 and Z-7-08 through Z-10-08**

**For the development of an approximate 3,300 acre industrial park with a railroad intermodal facility in the I-2 General Industrial District or, in the alternative I-T Intermodal Terminal District, if the proposed text amendment to the Zoning Ordinance docketed as ZO-1-08 is hereafter approved by the Mayor and City Council.**

**The site is roughly bounded by Vetter and Paterson Roads on the west, Laraway Road on the north, Millsdale Road on the south and Union Pacific Railroad on the east (see attached map for specific parcels and boundaries)**

**Joliet City Council** will receive the Plan Commissions recommendation and will conduct its public hearing on the annexation petition, classification and/or reclassification and agreement during a Special City Council meeting on Tuesday, July 29, 2008 at 6 p.m.

You are invited to attend the above mentioned public hearings to hear the presentation by the applicant and to speak in support or in opposition to the matter. Written comments to be included in the applicable packet must be received on or before the Wednesday before the applicable meeting. Written comments are to be forwarded and labeled CENTERPOINT to the Planning and Economic Development Department at 150 W. Jefferson Street, Joliet, IL 60432.
